



To Growers Hauling to O'Meara,

July 25, 2025

This year there will be 2 groups for prepiling sugarbeets into O'Meara just as last year. The two groups are divided based upon % of planted acres going into O'Meara. The enclosed sheet will tell you which group you belong to.

**Group 1** is projected to start on **Thursday, September 11<sup>th</sup>** at 8:00 a.m. This group will be for growers hauling > 40% of their planted acres into O'Meara . You will be able to haul during: September 11, 12, 15-18<sup>th</sup>.

**Group 2** will start on **Monday, September 15**. This group is for those that haul <40% of their planted acres into O'Meara. You will be able to haul Sept. 15-18<sup>th</sup> .

O'Meara is in the 5th group rotation this year. We will start at 8:00 a.m. for Group 1 on Thursday, September 11<sup>th</sup>. There will be an update each day for closing and opening times. As always- this is subject to change depending on weather, inventory and factory slice. Prepila quota is at **6.1 tons/A**.

The spreadsheet also shows your prepila total quota for the O'Meara piling site. It is expected that you will haul your quota to O'Meara during these days.

Keep the rotobeaer close to the lifter to meet your quota. **Rotobeaing beyond your quota does not guarantee you will be able to deliver those tons.**

Delivery of O'Meara prepila beets will need to be delivered to O'Meara and not to the EGF yard.

If you are considering having someone else take your prepila ton allocation quota, please let Bob Joerger know this information asap. There is a prepila transfer quota agreement form that needs to be filled out prior to the start of prepila. Contact your Agriculturist for this form.

The "scale out" slips show your accumulating tons on the bottom, so you know where you are at after every load delivered.

O'Meara truckhaul allows ½ shift trucks for 24 hour growers based on the computed numbers for miles and beet acres. For example, if it shows 2 trucks under the 24-hour truck column and 1 truck under the 12 Hour A Shift column then you'd have 2 trucks for 24 hours and 1 additional truck only for the hours of 2 am -2pm shift.

\*\*\* O'meara has a 2 truck minimum for a 12 hour grower. The 2 truck, 12 hr. minimum grower, will have a 12 hour schedule that rotates each year. If a 2 truck minimum grower wants to be a 24 hr grower- they would only get 1 – 24 hour truck sticker. \*\*\*

The truck allocation is shown based on past 12 & 24 hour grower information. Please check your other sites to make sure that shifts to other stations match up to the same shift times and designations. If there is any discrepancy, please let Bob Joerger know asap for correction.

**\*\* Reminder:** trucks will need to go straight forward to get tare dirt after dumping beets-most drivers are doing this already. The option of backing up, towards the piler, under the tare dirt conveyor will no longer be accepted due to safety concerns of the ground crew and future plans for piler automation. We will continue to train and emphasize tare dirt placement to the back of the truck box.

**IMPORTANT: \*\*\*\*Be sure to have your stickers on your trucks before stockpile starts. \*\*\*\***

Keep current on harvest information for O'Meara on the ACSC grower website under Crookston.

Truck turnaround time is important to all of us. Under truck specs, pls check your trucks to do:

**Hoist Guidelines: • 30 seconds hoist downtime tandems and triples • 45 seconds hoist downtime semis**

**Total Unloading Time: • Tandems - 2.25 minutes • Tri-axles - 2.75 minutes • Semis - 3.50 minutes**

Check the dump valves on the trucks and have drivers be aware how to operate this function in lowering boxes.

A recommendation to keep faster turnaround times in O'Meara :

1. Have trucks be closer to the end dumps while waiting to go onto the piler when there is no need for trucks back through the end dumps. This really helps on turnaround times.

2. If your farm has a relatively large number of trucks vs. other growers- check with other larger growers to see if there's opportunities to be at another site on the same day(s)? Long truck lines increase truck turnaround times and cost you more money.

A driver training video is still available on the ACSC website to train and refresh drivers.

Truck cards will need to have Omeara-770 as the delivery site on them for delivery into Omeara.
